Definition

A non-market based financing mechanism based on a fund that distributes payments to participating governments on the basis of performance within a given regulatory regime (e.g. REDD+). A number of financing alternatives have been proposed such as developed nations' official development assistance, revenue from carbon permit auctions and funding from international institutions.
